## LETTER OF REPRIMAND

As a result of an Administrative Hearing held on November 9, 1988, the Ohio Veterinary Medical Board has determined that a Letter of Reprimand be issued to STANLEY GORLITSKY, D.V.M., as evidenced by the enclosed Adjudication Order, Findings of Fact, Conclusions of Law and Order of the State Veterinary Medical Board for violation of R. C. 4741.22 (R) and R. C. 4741.22 (Q).

Section 4741.22 reads in part as follows:

"The state veterinary medical board may . . . issue a reprimand, or suspend or revoke the license . . . of any person licensed to practice veterinary medicine who:

(Q) Permits a person not a licensed veterinarian, a veterinary student extern, or a graduate animal technician to engage in work or perform duties in violation of sections 4741.01 to 4741.29 of the Revised Code.

(R) Is guilty of gross incompetence.

According to the evidence presented at the Hearing, the Ohio Veterinary Medical Board has concluded, based on the evidence presented that you, have permitted a person not a licensed veterinarian, a veterinary student extern, or a graduate animal technician to engage in work or perform duties in violation of R. C. 4741.01 to 4741.29. The Board has directed that a written reprimand be issued to you for this violation.

Further, according to the evidence presented at the Hearing, the Ohio Veterinary Medical Board has concluded that you did perforate/tear all layers of the rectum of Truffaut with a fecal loop while extracting a fecal sample.

Your failure to recognize a problem from the actions exhibited by Truffaut and/or reported to you by Barbara Klonowski, Truffaut's owner, constitutes "gross incompetence" on your part, and as such you are in violation of R. C. Section 4741.22 (R). The Board has directed that a written reprimand be issued to you for said violation.

This letter is your reprimand which will become part of your permanent file maintained by the Ohio Veterinary Medical Board. This reprimand applies only to the findings on Count 3 and Count 4(a). The findings relevant to Count 1, Count 2, and Count 4(b) (c) and (d) are addressed separately.


